# National Pingtung University of Science and Technology Disclosure of Collecting, Processing and Using Personal Information of Exam-Takers

The following details of "Disclosure of Collecting, Processing and Using Personal Information of Exam-Takers" has been created by National Pingtung University of Science and Technology (NPUST) in accordance to Articles 8 and 9 of the "Personal Information Protection Act" (the Law).

- 1. Name of the institution where the collection, processing, and use of personal information are conducted: National Pingtung University of Science and Technology.
- 2. The purpose of collecting the applicant's personal information:

Administration of functions including: conducting entrance exams; application, notification of test scores, notification of admission decision, and verification of document; maintenance of databases, where the data is stored; statistical analysis, and research; compilation of student records, enrollment history and graduation record. The information will also be used for administering student's data after enrolling in NPUST.

3. Personal information will be obtained through the following sources:

Personal information submitted by applicants in person, by mail, or online.

- 4. The following categories assigned to identify various types of information:
  - (1) Basic Information: name, gender, date of birth, photo, ID number (ARC number or passport number), education background (school or the year of graduation), physical address, email address, phone number, emergency contact, low-income household proof, job information.
  - (2) Special conditions: NPUST will request additional information, such as examtaker's record, and personal health record for exam takers who are physically or mentally impaired, or have sudden illness before or during exam period.
- 5. Use personal information:
  - (1) Period of use: Applicants' personal information will have been archived for 8 years since 2023. The information will be destroyed when the date is due.
  - (2) Restriction: The information is used, under applicants' approval, in only Taiwan, including Penghu, Kinmen, Matsu or other areas.
- 6. Each exam-taker or student is responsible for the accuracy of all information provided. A correction or update and an authentic proof are required when submitted to NPUST for correction.

- 7. For applicants, missing personal information could present risk of not completing the registration, hindering notification of emergency matters, or failing to receive test scores.
- 8. Applicants have the following rights towards his/her own personal information: Request, browse, update, and correction; request for stop of collecting, processing, using or removal of personal information. Exam-takes shall submit required documents via hard copy, fax, or phone to NPUST. Details of how to exercise such request can be obtained through the Recruitment Brochure.
- 9. Upon request from authorized government agencies or law enforcement agencies, NPUST will provide applicants' information as requested.
- 10. Should the applicants request for stop of collecting, processing, using or removal of personal information, NPUST shall do it accordingly except: 1) Termination of collecting, processing, using or removal of personal information will interfere NPUST to meet the above-mentioned requests. 2) Request from authorized government agencies or law enforcement agencies for NPUST to submit exam taker's personal information.



# 1. Tuition and Miscellaneous Fees: The OCAC provide a subsidy of 20,000 NTD per student per semester. The student is responsible to bay the balance amount of the tuition and miscellaneous fees, which comes to 7,340 NTD per semester. The total of 4 semesters comes to 29,360 NDT.

# 2. Fees for Internship Materials: 2,500 NTD per semester; 10,000 NTD for 4 semesters.

- 3. Accommodation Fee: 7,129 NTD per semester; 28,516 NTD for 4 semesters. (The air-conditioning fee is calculated and charged according to the actual use, and the accommodation fees for winter and summer breaks is calculated separately).
- 4. Computer and Network Communication Fee: 300 NTD per semester; 1,200 NTD for 4 semesters.
- 5. Group Student Insurance: Charged each semester according to the fee regulations of the current semester.
- 6. Other: If there are expenses incurred during activities such as inter-class activities and company visits, the fees shall be paid according to the actual amount incurred.

#### **II. Qualifications:**

#### A. Basic Criteria:

a. Overseas compatriot students who were born and have lived overseas to date or have lived overseas consecutively for at least 6 years and hold the Alien Permanent Resident Certificate or Long-term Alien Resident Certificate in the place of residence overseas, which is found to be true by the overseas recommendation unit. The continuous residence overseas for 6 years refers to the 6-year period calculated backward from the deadline for the application referred to in the Admissions Brochure as the base date. Those who only meet the required years of continuous residence as of August 31, 2022, however, may also apply on the condition that the affidavit is provided. The OCAC will investigate and validate the duration of overseas residence from the deadline for registration to August 31, 2022. If the years of continuous residence are not fulfilled, the accepted status/eligibility for placement will be canceled.

#### Remark 1:

The first stage: Retroactively for 6 years from Dec. 31, 2022 (between Jan. 1, 2017 and Dec. 31, 2022).

The second stage: Retroactively for 6 years from Jun. 15, 2023 (between Jun 16, 2017 and Jun 15, 2023).

#### Remark 2:

"Overseas" means countries or regions other than Mainland China, Hong Kong, and Macao. "Continuous residence" means "a length of stay in Taiwan in any calendar year (January 1 through December 31) not exceeding 120 days". In other words, whether "continuous residence" is fulfilled or not depends on whether the length of stay in any calendar year (January 1 through December 31) in Taiwan exceeded 120 days during the above-mentioned 6-year period. When the start/end years during the said calculation period are not complete calendar years, however, it shall be determined by no more than 120 days of stay in Taiwan within the calculation period of each of such years.

#### Remark 3:

Under one of the following circumstances, the applicant is not considered as not fulfilling the continuous residence requirement. The length of stay in Taiwan is not included in the calculation of the duration of overseas residence (that is, the duration of overseas residence needs to be calculated retroactively). Enclose the supporting documents during registration to facilitate review.

- 1. Attended the OCAC's Overseas Youth Vocational Training Program (Note: "Not a Degree Program": Session 41 or earlier sessions).
- 2. Attended a technical training program approved by the central competent education administrative authority.
- 3. Attended an event held by the OCAC or by a government agency as determined by the OCAC or attended a Chinese Language and Culture Workshop offered by a Chinese language educational institution approved by the competent authority to recruit students overseas that lasted for less than two years in total.
- 4. Spent a total period of less than 2 years in Taiwan as an exchange student.

- 5. Spent a total period of less than 2 years of practical training as an intern in Taiwan as approved by a designated central competent authority.
- 6. Returned to their country for selective service and military service.
- 7. Stayed in Taiwan due to war, natural disasters, or pandemics that prevented him/her from returning to his/her place of residence overseas.
- 8. Stayed in Taiwan for other causes unattributable to the overseas compatriot that prevented him/her from returning to his/her place of residence overseas, with supporting documents available.

#### Remark 4:

Whether one holds the Alien Permanent Resident Certificate or Long-term Alien Resident Certificate or not may be determined by the status of citizenship or permanent residency acquired or the overseas compatriot identity endorsement to the ROC passport.

#### Remark 5:

The duration of stay in Taiwan that may be excluded from the calculation of continuous residence as a result of the COVID-19 pandemic is from March 11, 2020 to August 31, 2022. This rule is subject to adjustment on a rolling basis reflective of the pandemic and will be released on the OCAC's website at any time.

- b. Chinese-speaking and Chinese note-taking capabilities: Passing TOCFL level A1, or 240 hours of study in a Mandarin speaking environment. Students, who do have the above capabilities while applying to the program, enhance their Mandarin ability via the following tracks, and fulfill above 240 hours.
  - 1. Related Chinese learning channels
  - (1) Overseas compatriot school
  - (2) Local language school/ center for Mandarin learning or local educational institution approved by the OCAC
  - (3) Domestic school approved by the OCAC for undertaking related programs (physical course or distance learning).
  - (4) OCAC language Study Program for Compatriot Youth programs (physical course or distance learning).
  - (5) Domestic education unit distance learning or physical courses.
  - 2. Overseas Chinese students who graduated from independent Chinese middle schools or national/national type middle schools in Malaysia, and those who have Chinese language proficiency certified by the sponsor are exempted from attaching the test of Chinese Language Proficiency (TOCFL) listening and reading test A1 level or above certificates and transcripts, or Chinese language proficiency Proof of study hours.

- (1) Graduates of a Chinese Independent High School in Malaysia must submit an academic record transcript for the unified examination.
- (2) Those who attend a national or national type high school and take the SPM or STPM exams must take Mandarin and achieve a pass grade.
- (3) Good health, righteous conduct, no undesirable behavior.
- (4) Applicants need to have a guardian in Taiwan (preferably a relative who is able to represent the parents and exercise guardianship).
- (5) Those with prior household registration in Taiwan and whose ROC Passport does not show "pending compulsory military service".
- (6) Thai applicants who are not ROC nationals need to show their Thai nationality.
- (7) Applicants must have a valid passport. Those without a passport or on a travel visa may not apply for the program unless they are on a travel visa issued by Brunei that is valid for at least 3 years. Each recommendation unit (school) is asked to precisely review the information.
- (8) Those who have applied for cancellation of their ROC nationality, which is approved and documented, and yet to become a national of another country may not apply for the program.
- (9) People of Mainland China, residents of Hong Kong and Macao, or those holding a passport issued by Mainland China may not apply for the program.
- (10) Those holding a senior high school diploma of an international school in Myanmar that is determined by the local government authority in charge of schools or its approved professional educational accreditation group to be comparable to its equivalent in Taiwan and holding an ROC passport or whose ROC passport shows the overseas compatriot student status may also apply for studying in Taiwan as required herein.
- (11) An overseas compatriot student who received assistance in returning to Taiwan for studies and returned to his/her place of residence overseas, and having stayed in Taiwan for less than two years before been expelled or had his/her student status forfeited, may apply for returning to Taiwan to study again; but such re-application may only occur once. If the overseas compatriot student was expelled or had his/her student status forfeited after having been accepted to an educational institution because of failing academic performance or conduct or serious violations of the institution's requirements or convicted criminal offenses, however, he/she may not apply for returning to Taiwan to study again.

#### B. Admission eligibility

Fulfillment of the required "prospective department/school-equivalent academic attainment"; that is, a local senior high school diploma or its equivalent.

#### Remark 1:

The academic credentials of foreign schools shall be authenticated by an overseas office of the Taiwan government or the Overseas Chinese Cultural and Educational Service Center of the OCAC, or its

designated recommendation unit first. The academic credentials of Hong Kong or Macao schools shall be authenticated by an organization established or designated by the Executive Yuan in Hong Kong or Macao or by a private organization commissioned by the Executive Yuan. The academic credentials of schools in Mainland China (including foreign schools or their branches in Mainland China) shall be notarized by a notary public in Mainland China first and then authenticated by an organization established or designated by the Executive Yuan or by a private organization commissioned by the Executive Yuan. Academic credentials of overseas Taiwan schools and Taiwan schools in China do not need to be notarized or verified as they are of the same academic credential of schools of the same level in Taiwan.

#### Remark 2:

Those holding academic credentials of schools in China, Hong Kong or Macao are not considered to be residing overseas during the period of study where they obtained the foregoing academic credentials.

#### Remark 3:

Those with unfinished studies in a comparable school overseas equivalent to a senior high school in Taiwan or whose graduating grade is equivalent to a senior high school in Taiwan with required credits obtained for the required years of study in a senior high school in Taiwan and meeting one of the following criteria may submit the application with equivalent academic qualifications:

- 1. Suspension, expulsion, or repetition for at least two years for some reason, with only the last year of study left uncompleted.
- 2. Suspension or expulsion for at least one year for any reason upon completion of the first semester of the last year of study.
- 3. Failure to graduate for any reason, despite fulfillment of the required years of study.
- \* The number of years involved in suspension, expulsion, or repetition as mentioned above is calculated from the end date of the last fulfilled semester as shown on historical transcripts, the Certificate of Successful Completion, the Attendance Certificate for Transfer Students, or the Certificate of Suspension up to the deadline for registration in the year of entrance exam.

#### Remark 4:

Students holding the diploma of a foreign school whose graduating grade is equivalent to the second grade of a senior high school in Taiwan may submit the application with equivalent academic qualifications. Once accepted and placed, however, respective technical colleges will increase the number of credits to be fulfilled by them or extend their years of study for them.

Associate Degree: 2 years (An extension of 2 years is allowed.)

- a. Application form (automatically generated when the application is completed)
- b. Photocopy of overseas residence certificate (overseas residence ID or passport) or the passport of the Republic of China and the Overseas Compatriot Identity Endorsement

#### c. Academic certificates:

- 1. Academic certificates: a graduation certificate verified by the overseas agency or the Cultural Center of the Overseas Community Affairs Council or a sponsoring organization (Applicants submitting an equivalent education certificate must attach a course completion certificate). Applicants who graduated this summer and have not yet received the graduation certificates can submit the enrollment letter, but the graduation certificates must be given when you enroll (or a course completion certificate that also shows school transcripts through the years). The applicants who fail to submit the documents mentioned above are not qualified for enrollment and must return to the place of residence at their own expense. Applicants from Cambodia can provide a provisional graduation certificate verified by the Taipei Economic and Cultural Office in Ho Chi Minh City and submit the official copy when it is issued later.
- 2. The address of a school and study duration must be stated on the school transcript for the latest 3 years (equivalent to Grade 10<sup>th</sup> to 12<sup>th</sup>) verified by the Cultural Center of the Overseas Community Affairs Council or a sponsoring organization. (New graduates cam provides their school transcript without the results of the last semester when the results are not received.)
- 3. If a graduation certificate cannot be issued restricted to the education system of an overseas residential, the applicants need to submit a course completion certificate equivalent to the level of a high school.
- d. Declaration Statement (Attachment 1)
- e. Attendance sheet of Chinese learning hour (Attachment 2): Please refer to Appendix 3 for instructions.
- f. Other required documents:
  - 1. School transcripts for the latest 3 years.
  - 2. Autobiography (in Chinese or English): with a word limit of 1500, without a fixed format or restrictions to content.
  - 3. Study plan (in Chinese or English): with a word limit of 1500, without a fixed format or restrictions to content.

- 4. Supplementary document (optional): recommendation letters, language proficiency certificates, portfolios, event/student group participation, award certificates, and other additional document you think it significant to this application).
- \* The documents (3) and (4) above must be translated into Chinese (translation is not required for English documents). Both of the original, photocopied and translated documents must be verified by the overseas agency or the Cultural Center of the Overseas Community Affairs Council or the sponsoring unit. The official documents must be submitted and reviewed upon enrollment.
- \* Please submit ALL the documents mentioned above when you apply. Late application or the application with insufficient document is not be accepted. The list of applicants will be sent to the Overseas Community Affairs Council for further review for verifying identity of overseas Chinese. Ineligible applicants will be disqualified for the application.
- \* If any of the documents submitted are found forged, altered, borrowed, falsely used or false, applicants who have not enrolled will be disqualified from admission, and those who have enrolled will be expelled from the school and no certificate will be issued. Graduates or dropouts will lose student status and their degree certificates or certificates of study will be withdrawn. Applicants who involve the criminal liability part of forged documents in the criminal law shall be transferred to the judiciary for investigation according to the law.

#### VI. Results inquiry and review

#### A. Inquiry time:

The first tier begins at 09:00 AM on February 9, 2023 (Thursday) and ends at 12:00 on February 10, 2023 (Friday);

The second tier begins at 09:00 AM on July 20, 2023 (Thursday) and ends at 12:00 on July 21, 2023 (Friday).

- B. Inquiry path: Follow the links listed in the registration system.
- C. Score Review Method: Once the system is open for candidates to check their scores, applications for score reviews will begin. If candidates have any doubts about their scores, they must fill in the score review application form (see Appendix 4 of this brochure) and email it to gaad@mail.npust.edu.tw before the review deadline.
- D. The application for review is limited to one time. The scope of the review is limited to errors in the summation of the results and the registration of the results. A review of the data may not be proposed.
- E. If the result of review affects admission status due to increases or decreases in the scores, the candidate who applied for review may not raise any objections.

#### VII. Admissions

- A. The minimum admission standards and the actual number of admitted students are determined by the admissions committee of the university based on the candidates' performance. If the total score of the candidates does not meet the minimum admission standard, even if there are places, the quota may not be filled.
- B. A standby list of students may be made. After the admitted students have registered, if there are any vacancies, the standby students fill the enrollment quota prior to the deadline for the registration as stipulated in this brochure.

#### VIII. Release of rankings and notice of admission

A. Announcement of admissions list:

B. Admission Notice Announcement:

The first tier will be announced on the school's website at 14:00 on February 17, 2023 (Friday), and the second tier will be announced at 14:00 on August 1, 2023 (path: NPUST Homepage  $\rightarrow$  Administrations  $\rightarrow$  Office of International Affairs).

#### IX. Registration and Items of Attention:

A. Registration date and time (based on Taipei time, late applications will not be accepted):

First Tier:

Registration for formally admitted students will start at 09:00 on February 20, 2023 (Monday) and end at 12:00 on February 23, 2023 (Thursday).

Registration for standby students will start at 12:00 on February 23, 2023 (Thursday) and end at 17:00 on February 28, 2023 (Tue).

Second Tier:

Registration for formally admitted students will start at 09:00 on August 03, 2023 (Thursday) and end at 12:00 on August 09, 2023 (Wed).

Registration for standby students will start at 12:00 on August 9, 2023 (Wed) and end at 17:00 on August 14, 2023 (Mon).

B. For the candidates' convenience, registration may be done prior to submitting academic (competence) documentation. Upon admission, candidates must have with them the original documents of academic competence. These must meet the registration regulations and comply with relevant laws and regulations. Enrolment registration will take place after the documents have been verified. If any forgeries, alterations, fraud, or falsehoods are found documentation, student status will be revoked and no relevant proof of attendance will be issued. The legal responsibility will be borne by the student. If facts are discovered after the student has graduated, the degree certificate will be revoked and an announcement will be made to cancel graduation qualifications. If the applicants are found to

- be unqualified, their admission status will still be revoked in accordance with relevant regulations, regardless of the fact that they have taken the examination and been granted admission.
- C. Admitted students should register within the specified time according to the procedures stipulated in the Registration Intent Form (Appendix 6 of this brochure). A failure to complete the registration procedures within the time limit shall be deemed as a voluntary renunciation of admission qualifications. The school will grant the placement of students on standby and no appeal may be made.
- D. If admitted candidates declare that they have given up their admission qualifications, they are not allowed to apply for reinstatement of admission qualifications.
- E. If admitted, students are unable to enroll on time due to serious illness, military service or special mishaps (confirmed by the university), they may apply to retain their admission qualifications.
- F. Other registration regulations for each department, institute, program, and class (such as required and additional credits, subjects, graduation qualifications, etc.) shall be applied as usual.
- \* For the admitted students who have completed the registration process, the school will send a letter to the Committee. For Overseas Chinese Students, and the Committee for Overseas Chinese Students will cancel the qualifications of the previously admitted students to apply for the admission channels such as "individual application" and "unified distribution" for the academic year
- \* If the number of candidates registered for the first tier has filled the enrollment quota, the second tier will not be admitted.

#### X. Procedures for handling appeals from candidates

- A. Candidates who have any doubts or disputes about examination-related matters must make a formally submit their names in writing within 7 days of the date of the incident, and fill out the "Appeal Form for Candidates" (see Appendix 5 of this brochure) to appeal to the Admissions Committee. The school will handle the matter in accordance with the provisions of this brochure or the resolutions of the Admissions Committee meeting and reply to candidates by email or official letter.
- B. Other unfinished matters shall be dealt with in accordance with relevant rules and regulations. If the relevant rules and regulations are unclear, the university shall hold an Admissions Committee meeting to discuss the matter and make decisions.
- C. The number of appeals is limited to one per case.

#### XI. Other Precautions

- A. Students who come to Taiwan must follow the requirements below:
- a. For those holding a foreign passport, apply to an overseas office of the Taiwan government for an alien visa before coming to Taiwan by presenting the (1) ROC Visa Application Form (visit the website of the Bureau of Consular Affairs, MOFA: https://www.boca.gov.tw; click on Visa/Online Application Form/General Visa Application Form and provide the information requested for each field in detail sequentially, download it, print it out, and sign it), (2) passport (that is valid for at least another 6 months), (3) 2-inch color profile pictures with white background x 2 taken over the past 6 months, (4) placement notice, (5) Certificate of Sound Health issued over the past 3 months by an eligible foreign hospital approved by the Ministry of Health and Welfare or an overseas office of the

Taiwan government in the place of residence overseas (please contact the overseas office of the Taiwan government) (that is, the "Health Certificate for Residence Application". You can also visit the website of the Centers for Disease Control: http://www.cdc.gov.tw and click on International Travels and Health/Foreigner Health Management/Foreigner Student Health Checkup for more information), (6) authenticated "Parent Consent Form" and Household Registration Transcript (issued over the past 3 months) for those under the age of 20, and (7) other related supporting documents as required by the overseas office of the Taiwan government and apply for the Overseas Compatriot Resident Certificate within 45 days following arrival through the "Online Application System for Foreign and Overseas Compatriot Students" of the National Immigration Agency. If the place of residence has no foreign hospitals approved by the Ministry of Health and Welfare, please contact the Taiwan government's agency abroad and apply for a visa in accordance with local visa regulations.

Overseas compatriot students holding a Thai passport, when applying for a visa with the overseas office of the Taiwan government in Thailand and upon arrival at our airport or harbor following acceptance and placement, shall have their proof of Thai citizenship validated.

- b. For Taiwan nationals without a household registered in Taiwan, apply with the overseas office of the Taiwan government in the place of residence overseas for transfer to the National Immigration Agency by presenting the documents below: (1) Application Form (include 1 photo of the same specification as that shown in the National ID card), (2) identification supporting documents in the place of residence overseas, (3) ROC passport or other documents sufficient to prove ROC nationality, (4) Certificate of Police Records in the place of residence overseas (not required for minors if not available in the place of residence overseas), (5) Certificate of Sound Health issued over the past 3 months by an eligible foreign hospital approved by the Ministry of Health and Welfare or an overseas office of the Taiwan government in the place of residence overseas (please contact the overseas office of the Taiwan government) (that is, the "Residence or Settlement Health Examination Checklist". You can also visit the website of the Centers for Disease Control: http://www.cdc.gov.tw and click on International Travels and Health/Foreigner Health Management/Foreigner Student Health Checkup for more information), (6) placement notice and other related supporting documents; once approved, the single-entry permit and a duplicate copy of the resident certificate for the region of Taiwan are issued. Pick up the original resident certificate for the region of Taiwan at the National Immigration Agency within 3 months from the next day of arrival by presenting the duplicate copy of the residence certificate for the region of Taiwan. Those already in Taiwan must apply for the residence certificate from the NIA with all documents mentioned above and the exit and entry permit.
- c. Those with a household registered in Taiwan shall register their move-in with the local Household Registration Office within 30 days upon arrival with a show of the ROC passport affixed with the entry stamp or a copy of the entry permit; there is no need to apply for the residence certificate separately.
- B. In case of falsification, spoofing, or fabrication found in any submitted document, the accepted status will be canceled and the student status will be revoked for those who have been enrolled and no academic certification will be issued. The student shall return to their place of residence overseas at his/her expense.
- C. Males are subject to conscription from January 1 of the year following them turning 18 years old in December 31 of their 36th years of age; during this period, they are referred to as the service-age men (the servicemen). All servicemen with Taiwan nationality whose household was once registered must fulfill their obligation of military service during the period of near conscription age, regardless of

whether they have moved abroad or have another nationality. They must hold their Republic of China passport when entering or leaving Taiwan. An overseas compatriot student entering Taiwan with a foreign passport will be listed in their entry and exit records during their stay in Taiwan. Those who are not overseas compatriot servicemen entering Taiwan will be listed as general servicemen despite their dual nationality identity. If a student is required to perform military service as set forth by the law, they will be restricted from leaving Taiwan until the service has been fulfilled.

- D. Overseas compatriot students who are servicemen through prior or current households registered in Taiwan are asked to apply for deferred conscription as required while studying in order to protect their schooling rights. Upon graduation or departure from the school, the cause of deferred conscription is no longer. Overseas compatriot students who are servicemen shall follow applicable military service requirements for them. However, if during school, after graduation, or after leaving school, the overseas compatriot student is longer identified as an overseas compatriot serviceman, he will be subject to regulations for general servicemen. He will be required to perform military service in accordance with the law. For questions relating to military service, please check with the National Conscription Agency.
- E. Overseas compatriot students who are servicemen, with overseas compatriot identity endorsement, who return to Taiwan to study in an equivalent or a lower-level school after having graduated from a foreign senior high school or above, do not meet the criteria for deferred conscription as students under Article 4 Paragraph 2 of the Conscription Regulations for Naturalized Aliens & Returning Overseas Chinese.
- F. Overseas parents of a student shall have one of their relatives in Taiwan as the student's guardian to look after the student. The Taiwan government agency overseas and recommendation unit must ask the applicant to name their guardian in Taiwan on the application form, which will be checked upon school registration. The guardian will be contacted by the school. For those who have filled in false information about themselves, the school has the right to request an extended deadline. After the deadline, the student's place at the educational institution may be revoked and asked to return to their home country within a given date at their own expense.
- G. To facilitate the care of and protect the safety of students by the school, all students of the Overseas Youth Degree Program must stay in the school dormitory.
- H. Once admitted to the school in Taiwan, students are to follow the applicable requirements for inquiries about grades, suspension of studies, and transfers. Students of the Overseas Youth Degree Program may apply for a transfer to another department or school (no restrictions on departments) during the second semester of the first year. They may, however, only transfer to departments or schools within the Overseas Youth Degree Program and the number of openings available at the school the students are transferring to may not exceed that of the existing class and applicable requirements shall be followed.
- I. Overseas compatriot students may not apply to study any recurrent or continuing education bachelor's degree program or in-service master's degree program at any cram school, college (institute) of continuing education, or in distance learning mode at any university, college, or junior college, or any other program which is only taught in the evening or during vacations. Overseas compatriot students who have already obtained legal resident status in Taiwan for non-study related purposes are not subject to the restriction. Overseas compatriot students who are in breach of the previous provision shall have their registration as a current student cancelled and will not be awarded any certification whatsoever regarding their related academic undertakings. If such a breach is

- discovered after graduation, the educational institution shall revoke the former student's eligibility to graduate and shall require any degree already awarded to be returned and rescinded.
- J. An overseas compatriot student who has graduated, or has voluntarily discontinued or suspended their studies for the maximum allowable period, and who is not continuing to pursue studies will lose their status as an overseas compatriot student. An overseas compatriot student whose student status has been cancelled will have their overseas compatriot student status reinstated if they resume their studies at a higher level, transfer to another educational institution, or resume studies that they had discontinued.
- K. If an overseas compatriot student is engaged in activities not answering to the purpose of their visa, working illegally, or using forged or fabricated documents, among other illegal acts while studying or after graduation or voluntary expulsion, forced expulsion, or suspension of studies, he/she will be pursued as required by law.
- L. If NPUST is found to be involved with an intermediary while recruiting students, the school's eligibility in the program will be removed by Overseas Community Affairs Council.

- (4) There will be no damage to public properties; otherwise, it will be paid for at the price it is worth.
- (5) Students will stay in the dormitory as required while studying in Taiwan.
- (6) Students shall be capable of Chinese listening comprehension and conversing and communicating in Chinese as well as Chinese note-taking.
- (7) Those expelled for some reason shall leave the school within a week and depart Taiwan and return to their place of residence overseas as soon as possible.

#### **Instructions for Logging Chinese Language Study Hours**

#### I. Origin of the plan

In order to cooperate with the implementation of the strengthening population and immigration policy, and expand the cultivation and retention of overseas Chinese talents, the Overseas Chinese Affairs Committee (hereinafter referred to as the Association) actively handles overseas enrollment operations, and aims to increase the number of students by 3 times. , and the number of overseas Chinese students studying in Taiwan has been increasing day by day in recent years. In order to improve the Chinese language ability of overseas Chinese students studying in Taiwan, make them integrate into Taiwan's study and employment environment, and understand the Chinese language learning process of overseas Chinese students, this guide is specially formulated.

#### II. Program objectives

In order to improve the Chinese language ability of the overseas Chinese students who come to Taiwan for further study, the overseas Chinese students studying in Taiwan since the Ming Dynasty (112) must meet the standard of A1 or above in the Test of Chinese Language Proficiency (TOCFL), or study hours exceeding the national Chinese language. 240 hours as recommended by the Quiz Promotion Task Force.

- III. Applicable objects: From next year (112), overseas Chinese who are going to study in the industry-university cooperation special class (industry-bringing special class) and the two-year associate degree program (Haiqing degree class) of the overseas youth technical training class pregnancy.
- IV. Applicable standards (detailed table of standards for the Overseas Chinese Affairs Committee to recognize overseas students with Chinese language listening and note-taking abilities):
  - A. Test of Proficiency in Chinese Language (TOCFL) Listening and Reading Test Level A1 or above or Chinese language learning hours must be over at least 240 hours.
  - B. Related Chinese learning channels:
    - a. Overseas Chinese (Chinese) schools.
    - b. Local language schools/Chinese language centers or local educational institutions approved by the Association.
    - c. Schools recognized by the Association to host industry-leading special classes and Haiqing degree classes (entity or distance video teaching courses).
    - d. Overseas youth language seminars of the Association (entity or distance video teaching courses).
    - e. Physical or distance video teaching courses of domestic educational institutions (such as Chinese language teaching centers of various universities) approved by the Association.
  - C. Overseas Chinese students who graduated from independent Chinese middle schools (independent middle schools) or national/national-type middle schools in Malaysia, and

those who have Chinese language proficiency certified by the sponsor are exempted from attaching certificates and scores above A1 in listening and reading tests of the Test of Chinese Language Proficiency (TOCFL) Single, or proof of the number of hours of Chinese language learning, the method of acceptance is explained as follows:

- a. Graduation from independent Chinese secondary schools (independent secondary schools): must have a unified examination report card.
- b. National/National-type secondary school graduates: Those who take the "Malaysian Diploma of Education (SPM)" or "Malaysian Higher Education Diploma (SPTM)" examination must take the Chinese language subject and pass the test.

#### V. How to log in to study hours

- A. Online registration is adopted. Overseas Chinese students who sign up for the special classes of the Association must log in to the "Overseas Chinese Affairs Activity Registration System" of the Association to register the number of study hours and upload supporting documents (such as completion certificates, copies of transcripts, or issued by the Chinese embassy abroad) supporting documents).
- B. Overseas Chinese students who sign up for our special classes, if they pass the Test of Chinese Language Proficiency (TOCFL) listening and reading test A1 level or above before registration, and obtain a transcript or certificate, upload the test results to the "Overseas Chinese Affairs Activities Registration System" Certificate or certificate, no need to register Chinese language learning hours.
- C. If you are a graduate of a Chinese independent high school (independent high school) or a national/national type high school in Malaysia, and you have been certified by the sponsor to have Chinese language proficiency, upload the following supporting documents respectively, and you are exempt from the Chinese language proficiency test for listening and reading Proof of A1 level or above in the test or proof of the number of hours of Chinese language learning, the description is as follows:
  - a. Graduation from Chinese Independent Secondary School (Independent High School): Unified Examination Transcript.
  - b. National/National-type secondary school graduates: Those who have taken the "Malaysian Diploma of Education (SPM)" or "Malaysian Higher Education Diploma (SPTM)" examination must take the Chinese language subject and pass the test.
- D. Overseas Chinese students must upload the supporting documents listed in the above three items during the registration period of each special class.
- E. After registering the number of study hours and uploading supporting documents, overseas Chinese students need to download the notification letter of registration completion or print the registration form through web page printing before confirming the submission of materials, and submit it at the time of registration.

#### VI. System operation mode:

A. Overseas Chinese students must go to the "Overseas Chinese Affairs Activities Registration System" website to register as a member (URL: https://register.ocac.gov.tw), fill in their email address and personal information, and press the "Register" button.

- B. Receive the "Member Registration Verification Letter" from the "Overseas Chinese Committee Activity Registration Mailbox" to your personal email address, open the letter and click the "Link Verification".
- C. After the verification is successful, please enter your email address, password and verification code, and then click "112-year Overseas Chinese Students Enroll in Industry-University Cooperation Special Class for Overseas Students and Overseas Youth Technical Training Class Two-year Associate Degree Class Chinese Verification of Literature Study Hours".
- D. After registering the number of learning hours and uploading the supporting documents, the system will automatically send a letter of "Successful Registration" to complete the registration of Chinese language learning hours.

#### VII. Review assignments:

- A. Preliminary review: After overseas Chinese students complete the registration of Chinese learning hours, the overseas embassies or the Overseas Chinese Education Center of the Association will conduct the preliminary review.
- B. Re-examination: The subcontractors of the association will conduct the re-examination, and specify in the admission notice whether they meet the standards of the "Standard Form for the Overseas Chinese Affairs Committee to Admit Overseas Chinese Students with Chinese Listening and Note-taking Ability". If the number is less than 240 hours, the number of study hours that should be supplemented shall be stated separately.

#### VIII. Remedial measures:

When overseas Chinese students enroll in the special class or Haiqing degree class, if the registered Chinese language learning hours do not reach 240 hours, they must choose one of the following remedial measures after admission to the end of the first academic year to strengthen their Chinese language Ability, and make up the learning hours according to the learning channels adopted in the standard table:

- A. Take the listening and reading tests of the Chinese Language Proficiency Test, and obtain a grade of A1 or above, and upload the transcript or certificate of the Chinese Language Proficiency Test to the "Registration System for Overseas Chinese Affairs Activities".
- B. Before coming to Taiwan to study, attend the "Overseas Youth Language Seminar" organized by the Association, obtain a certificate of completion, register the number of study hours and upload a copy of the certificate.
- C. Participate in Chinese language courses offered by domestic educational institutions (Chinese language centers attached to major schools), obtain a certificate of completion, log in the number of study hours in this system and upload relevant certificates.
- D. Participate in the remedial courses offered by the school and pass the relevant tests to make up for the lack of study hours. After obtaining the certificate or transcript issued by the school, register the study hours in this system and upload the relevant certificate.
- IX. This instruction will be implemented after approval and may be revised according to actual needs.
